You are requested to report on 13-06-2019 as indicated above along with the following original certificates / documents (with one photocopy of each), failing which you will not be permitted to participate in the counseling.

1. Original Marksheet of (10+2) or equivalent examination
2. Original 10th (High school) certificate for proof of age
3. **Original certificate obtained from Indian diplomatic mission / chancellery / high commission under their seal to the effect that the candidate or the person sponsoring him / her is Non-resident Indian in that country presently. Please note that in the absence of this certificate the candidature will stand cancelled**
4. Original document / certificate clearly indicating that the candidate is real brother / real sister /real son / real daughter
5. A letter from NRI certifying that he / she is sponsoring the candidate and is ready to bear educational expenses of the candidate for the entire duration of the programme
6. Three passport size recent photographs
7. If the number of candidates appeared are more, the counseling may continue till late hours and / or may continue following day. Therefore, candidates are required to come prepared accordingly.

You are also required to bring two **separate account payee bank draft of Rs.1000** as counseling fee (non-refundable) and bank draft of **Rs.10,000** as an advance fee respectively, each in favor of **"FINANCE OFFICER, DR. APJ ABDUL KALAM TECHNICAL UNIVERSITY, UTTAR PRADESH"** payable at Lucknow. You may note that CASH payment will not be accepted under any circumstances.

Please note allotment of seats is not guaranteed to every candidate called for counseling.

As per the existing U.P. Govt. Order, the tuition fee for the NRI candidate is \$7,000.00 (USD 7000) per year. The selected candidates have to deposit the fee in the allotted institute latest by 22-06-2019 to secure his/her admission failing which the allotment shall stand cancelled.
